## 'Sky is the limit' for ECCC's diesel technology

Mayor James Young said he believes the Diesel Equipment Technology class that East Central Community College will be starting in August in Philadelphia will fill a big training need for Neshoba County and East Mississippi in general.

"The sky is the limit," Young said. "This is going to give students who are in school an opportunity to sign up to get quality, high

level mechanic training right here.

"There is a big need and a big market for these skills. Not only for diesel repair but for truck drivers; those who want to do something positive and create a career," Young said. "I am thankful for East Central and the board of aldermen here that took a big step of going beyond the routine to try and make this project happen. It is about the now and future."

The city of Philadelphia has approved for a contractor to begin renovation work on one of the outer buildings at the old U.S. Motors plant. It will be transformed into a modern classroom and teaching center. It will have its own parking lot and entrance. The bid was for \$418,234 was accepted earlier this month

Classes are set to start August 12.



Right now, ECCC is looking for an instructor. The job is on the ECCC website.

"The job is opened until filled," Stewart said. "We have had a couple of inquiries but through that process. If anyone is interested, it is on our website."

ECCC is also involved in getting the program approved by the Southern Association of Colleges and Schools Commission (SAC). ECCC has its application in and is answering questions as they come up. It is hoped this process will be completed by May or June.

Having an instructor on board will help ECCC to get the program accredited.

Students will have three options. A 60-hour Associate of Applied Science degree is being offered. There will be 45 hours for diesel mechanics skill and technical training and 15 hours will be for academics. There are also certificate programs for 30 hours and 45 hours, all focused on diesel mechanics.

"We are excited to offer Diesel Equipment Technology at ECCC," said Wayne Eason, ECCC director of Career and Technical Education. "Businesses and industries in our district have expressed a great need for these technicians. We look forward to training our future workforce and filling this need with qualified technicians."

Coursework will include Fundamentals of Equipment Mechanics, Electrical/Electronic Systems I, II, and III, Hydraulics I, Diesel Systems I, II, and III, Preventive Maintenance and Service, Transportation Power Train, Air Conditioning and Heating Systems, Advanced Brake Systems (Air), Steering and Suspension Systems, and Heavy Equipment Powertrain.

According to recent statistics by the Mississippi Department of Employment Security, experienced diesel technicians in the East Central Community College area can earn up to \$26.12 per hour or \$54,324 annually.

To be considered for the program, prospective students must complete the online ECCC application for admission at www.eccc.edu, and submit all official high school and college transcripts or an official high school equivalency diploma.



#### NESHOBA GENERAL HOSPITAL

Philadelphia is home to Neshoba General Hospital and Nursing Home where the medical staff offers a variety of specialties in areas ranging from family medicine to pain management.

Neshoba General Hospital's emergency room is a designated Level IV Trauma Center. The hospital operates a paramedic-level ambulance service.

In 2001 a distribution center (60,000 sq. ft.) opened and now ships product to customers worldwide.

In 2003 the plant in Philadelphia became ISO 90001-2000 Certified and re-certified in December 2015 to ISO 9001-2008.

of seed and fertilizer without seedbed preparation. Acceptance of these products encouraged the decision to expand the agricultural, forestry and reforestation product lines.

The early 1950s brought the development of the Yardster fork-lift trucks.

These rugged machines soon


found widespread acceptance in the handling of heavy and bulky materials such as lumber, prestressed concrete, steel and other primary metals, and containerized freight.

A line of pulpwood handling equipment, including the Pulpwood Dream and pulpwood Yardster followed and rapidly became the accepted standard for loading and unloading pulpwood in the growing number of concentration yards throughout the southeastern United States.

By the mid-1960s, Taylor Machine Works had one of the most advanced machine shops in the South, with heavy investments in modern machine tools.

Products included a complete line of heavy duty trailers (for transporting gravel, soil, etc.), numerous agricultural implements, reforestation equipment, log loaders, and other specialized machines in addition to the major line of fork-lift trucks.
